



# Consortium Process

## AAS – Energy Tech- Power Operations (PPO)

1. Submit or update your Free Application for Federal Student Aid (FAFSA) to include Centralia College, school code 003772
2. Apply for admission to Centralia College on-line at [www.centralia.edu](http://www.centralia.edu)
3. Request copies of official academic transcripts from all schools, including Wenatchee Valley College, that you have attended within the last 5 years and have them sent to Centralia College
4. Complete and submit to the Financial Aid Office at Centralia College the following forms. Both can be downloaded from the Centralia College web site at [www.centralia.edu](http://www.centralia.edu) under the forms section of the financial aid page.
  - a. Centralia College Financial Aid Data Sheet
  - b. Consortium Request - *CC & Wenatchee Valley College (must be done each quarter)*
5. Submit to the Financial Aid Office at Centralia College the following:
  - a. an educational plan listing all Wenatchee Valley and Centralia College classes and which quarters that you will be taking each class
    - i. Wenatchee Valley classes that are covered by this consortium are listed below
  - b. a copy of your Wenatchee Valley class registration (**must be done each quarter**)
  - c. a concurrent enrollment form – so tuition is charged correctly (**must be done each quarter**)
  - d. an unofficial copy of your Wenatchee Valley College transcript (**must be done at the end of each quarter after grades have posted**)
