**Veterans**

Child and spouse of totally disabled POW/MIA or deceased eligible veterans or national guard members tuition waiver 100 percent

**On Space Available Basis**

State Employee Waiver \$20 per quarter up to two classes  
*(includes classified employees, public higher education employees, half-time or more, state, and k-12 employees)*

Senior Citizen Waiver \$5 per quarter up to two classes + fees

\*\*Students exempt from student use fees are ABE, ESL, Running Start, SNRC, HMFL, FMGT, SMGT, Apprentice, and EMT. Community Service students pay a fee with the class.
