Veterans

Child and spouse of totally disabled POW/MIA or deceased eligible veterans or national guard members tuition waiver 100 percent

On Space Available Basis

State Employee Waiver \$20 per quarter up to two classes
(includes classified employees, public higher education employees, half-time or more, state, and k-12 employees)

Senior Citizen Waiver \$5 per quarter up to two classes + fees
