## Verification of 2020 Income Information for Tax Filers

---

**TAX RETURN FILERS:** The instructions below apply to the student and spouse, if the student is married. Notify the financial aid office if you or your spouse filed separate IRS income tax returns for 2020 or you had a change in marital status after December 31, 2020.

**Instructions:** Complete this section if you and/or your spouse (if married), filed or will file a 2020 IRS income tax return(s). *The best way to verify taxable income is by using the IRS Data Retrieval Tool (IRS DRT) that is part of FAFSA on the Web at FAFSA.gov.* In most cases, no further documentation is needed to verify your 2020 income if you transfer your information into the FAFSA using the IRS DRT if that information was not changed.

A **2020 IRS Tax Return Transcript** may be obtained through:

- Get Transcript by Mail – Go to [www.irs.gov](http://www.irs.gov), click “Get Your Tax Record.” Click “Get Transcript by Mail.” Make sure to request the “Return Transcript” and **NOT** the “Account Transcript.”
- Automated Telephone Request – 1-800-908-9946.
- Paper Request Form – IRS Form 4506T-EZ or IRS Form 4506-T. This option must be used if you or your spouse had an address change since filing your 2020 tax return(s).

### Tax return transcripts are generally received within 10 business days form the IRS’s receipt of the request.

If you are married and you and your spouse filed separate 2020 IRS income tax returns, the IRS DRT cannot be used and a tax return transcript or signed tax return must be provided for both of you. For students who have experienced a change in marital status: 1) If you have become married since filing your 2020 income tax return, then you will need to provide a 2020 IRS Tax Return Transcript or signed tax return for both yourself and your spouse (if taxes were filed). 2) If you have separated from your spouse and are now divorced from your spouse, then provide a 2020 IRS Tax Return Transcript or a signed copy of your 2020 tax return, along with any W2 form(s) for both yourself and your spouse so the income can accurately be separated.

Any individual who files an amended IRS income tax return for tax year 2020 must provide a copy of their 2020 IRS Form 1040X, "Amended U.S. Individual Income Tax Return," in addition to their Tax Return Transcript from the IRS or signed copy of 2020 tax return (that will only include the information on the original tax return) and the applicable schedules.

Any individual who was the victim of IRS tax-related identity theft must provide a Tax Return DataBase View (TRDBV) transcript obtained from the IRS and a statement signed and dated by the tax filer indicating that he or she was a victim of IRS tax-related identity theft and that the IRS is aware of the tax-related identity theft.
